## <u> Awareness & Presentations: MV Campus</u>

- Walk into My Future. September 27, 2019: 70 students participated.
  - ECR and Peace Studies worked together to introduce students to historical peace figures and the impact each had in making positive, non-violent change.
- Presentation, Alicia Dailey's Human Conflict Class. November 01, 2019: 17 attended.
  - Theresa gave an introductory presentation on communication styles, the effectiveness of communication, and normalizing conflict.
- Presentation, Alicia Dailey's Human Conflict Class. November 11, 2019: 21 attended.
  - Theresa gave a presentation on the sources of conflict, managing those sources, obstacles to communication, roles of perception in conflict, and defining active listening.
- VIA: When Conflict Comes to Dinner. November 12, 2019: 129 students and 10 others attended.
  - An interactive event. An improv group presented a family conflict and participants were invited to identify alternatives to navigating difficult conversations. Participants were also invited to explore their personal position related to conflict and their own comfort level with it. They were provided with some tools to help them navigate difficult conversations they might encounter.
- Presentation, First Year Experience. November 18, 2019: 22 attended.
  - Theresa gave an overview of productive communication, highlighting basic problem solving skills. Students were also provided an opportunity to practice positive communication skills regarding conflict situations and discerning best practices for responding.
- Presentation, Alicia Dailey's Human Conflict Class. November 25, 2019: 17 attended.
  - Theresa gave a presentation on the use of "I" statements and when silence is appropriate. It included some role play/scenario practice regarding conflict situations and discerning best practices for responding.

  - [1] Playing Well with Others. Theresa presented on how teams form and team dynamics.
  - [2] It's All About Perspective. Theresa gave a presentation on seeing the world through another's lens.

- Presentation [virtual], Peace Week. March 31, 2020: 8 attended.
