She Buried the Lead, but Look for It. The Good News is Coming



Letter from the ECR Executive Director: Linda Troop

Hello, friends, patrons, clients, and supporters of **ECR**'s work in the community. It has certainly been an eventful summer and fall for **ECR**. Because a number of surrounding counties asked us this spring to provide a training for their volunteers to become **S**chool **A**ttendance **M**ediators (**SAM** Mediators), I drafted three of our Board members and seasoned mediators, Angie Briner, John Horn, and Jan Rhoades, to help me create a new **ECR** training course.

It was a project that demanded hours of our time doing tasks like revising the original 33-page **SAM Training Manual** to a 60-page workbook, developing curriculum content and learning activities for three 2-hour Zoom sessions, and creating mock **SAM** scenarios for the in-person 6-hour Roleplay Day. It was a huge undertaking and we weren't entirely sure anyone would register for the June and September trainings, but they did. "If you build it, they will come." Between the two trainings, we reached 25 volunteer participants from four counties (Steuben, Huntington, Kosciusko, and Wabash.) The registration fees for these two trainings brought in much-needed revenue that was clear of expenses to our organization because the \$5,000 Good Deeds Grant we were awarded last March by The Community Foundation of Wabash County covered the cost for instructors, curriculum development, and instructional materials.

But are you thinking I may have dropped the lead? Well, a good journalist would say so because I failed to open with a fantastic piece of news that we received on September 25. It was an ordinary day, as they say; yet, as I returned home exhausted from an **ECR** in-person committee meeting, I opened my email to find this statement:

"I'm pleased to share that Lilly Endowment has approved a grant to **Education for Conflict Resolution, Inc.** as indicated below. Congratulations!"

Amount: \$20,488 Purpose: Strengthening Youth Programs in Indiana 2023

It made my day. It is a miracle of sorts that the Lilly Endowment even considered our application and decided to grant us these funds. When I applied last May, I really had no hope that the granting committee would consider **ECR**. We were too small in terms of yearly budget. They only wanted agencies whose annual budget is \$60,000 or more to apply. That is not us. Also, **ECR's SAM** Program did not reach high enough numbers of youth (approx. 50 annually). Yet, when I made the argument that by training volunteers from counties outside of Wabash in how to initiate a **School Attendance Mediations** Program, we would ultimately be reaching 1000's of youth across the state, they were interested.

I have to say that in this, the 35th year of **ECR's** history as an organization, we could not have been any better rewarded than to have been recognized by Lilly with funds to support our work. We hope you are excited and joyful for us as well!
